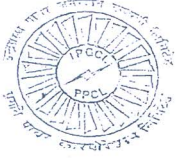

**Sub: DEBARRING FROM PARTICIPATING IN FUTURE TENDERS  
FLOATED BY IPGCL-PPCL FOR THE PERIOD OF TWO YEARS  
IN PLACE OF 03 YEARS W.E.F. 10.07.2019**

Sir,

This is with reference to the Tender No. IPGCL-RESCO Part C/06/2018, floated for implementation of 30 MW grid connected roof top Solar PV System on Government buildings in the State of NCT of Delhi under RESCO Part C Model. Thereafter Letter of Allocation No. IPGCL/RFS/RESCO Part C/06/2018-19/139 dated 31<sup>st</sup> August 2018, was issued in your favour.

Since you did not comply with the provisions of the terms of tender document, therefore invoking the Clause 9 of the tender document, your firm was debarred from the future participation in IPGCL-PPCL tenders for the period of 03 years from the date of issue vide Letter No. IPGCL/RESCO Part C/06/2019/613 dated 10.07.2019.

You have requested vide letter dated 14.02.2020 to reduce the debarring time to already undergone mentioning that you have suffered a lot and this would affect the livelihood of the company's employees and their family.

In this regard it is to mention that IPGCL has the discretion to debar the party for a period up to 5 years as per the General Terms & Conditions of NIT.

However, keeping a lenient view by the Competent Authority to your request and honoring the directions of the High Court, the debarring period is reduced from 03 years to 02 years w.e.f. 10.07.2019.
