SUBJECT: Debarring from participation in future tenders floated by IPGCL-PPCL for a period of five years w.e.f. the date of issuance of this letter.

Dear Sir(s),

1. This is with reference to Tender No.1000010604/CS-II/PPS-I/20-21 regarding Annual Rate Contract for the maintenance of Electrical system at Pragati Power Station-I for the year 2020-21 floated by PPCL.
2. The reference tender was uploaded on Delhi Government e-procurement portal vide tender ID: 2020_IPGCL_188141_1 with BSED: 24.03.2020 and BOD: 26.03.2020.
3. Your firm has participated and submitted the technical bid on Delhi Government e-procurement portal by due date of opening.
4. Technical bids of participated vendors were decrypted, downloaded and authenticated by Tender Opening Authority on Bid Opening Date i.e. 26.03.2020.
5. **While scrutiny of the submitted documents, it was found that your firm had submitted tampered, ambiguous and manipulated documents which were confirmed from issuing organization i.e. NTPC.**
6. In this regard an email was sent to your firm i.e. M/s J P R Construction & Company on dtd.29.05.2020 and reminder on 05.06.2020 to submit original copy of PO No.4000205360-046-1014 dated 22.09.2018 for Annual rate Contract for the maintenance of electrical system of Main plant / Off-site / PA System / Testing lab etc of DGPS submitted by your firm but no reply received so far.
7. Further, a show cause notice was served on dt. 29/06/2020 to your firm M/s JPR Construction Co. and asked to submit your reply / clarification, but again no reply received so far.
8. PPCL NIT (General Terms and Conditions for Contract) Clause No.37 states as under:
"IPGCL/PPCL may, as its sole discretion, blacklist/debar any supplier/contractor for participating in any tendering process with IPGCL/PPCL, who indulges or is suspected to be indulged in unethical practices while dealing with IPGCL/PPCL.
Banning of vendors for future dealing will be done:
i) In case unethical business practice is established against a vendor.
ii) Vendor furnishes wrong information or manipulated documents.

iii) Vendor is charged with CBI investigation for an offence against Govt. regulation and subsequently in a court of Law".

9. As above, your firm indulged in unethical practices by furnishing wrong information / manipulated documents.

10. With the approval of the competent authority, your firm i.e. M/s J P R Construction & Company is hereby Debarred for participating in any tendering process with IPGCL/ PPCL and Blacklisted for a period of five years w.e.f. the date of issuance of this letter.
