**OFFICE ORDER**

**Sub: - Recognition of hospitals/nursing homes/diagnostic centres on the panel of IPGCL/PPCL including those offering credit facilities for indoor treatment for the year 2011-12.**

In continuation of Office Order No. CMO/09-10/F.1/505 dt. 03.02.2010 and subsequent Office Orders No. CMO/10-11/F-1/143 dt. 21.06.2010, competent authority is pleased to extend validity of existing panel of recognized Hospitals/ Nursing homes and Diagnostic centers with following addition/deletion/change in category:-

**Additions :-**
